OREGON COUNCIL TO PARTNER WITH BLM ON NATIONAL PUBLIC LANDS DAY

After three very successful reclamation efforts in 2019, 2020 and 2021, I am happy to inform you that the Council will continue our remediation work at Hampton Butte in 2022. As you probably know, this collection area is famous for green petrified wood and has been extensively dug for many years. In cooperation with the Prineville Bureau of Land Management, and in an effort to demonstrate best rockhounding practices (AFMS Code of Ethics), the Oregon Council is again sponsoring a work party at Hampton Butte on Saturday, September 24, 2022 from 9:00 am until 4:00 pm. This date coincides with National Public Lands Day and this project is the Council's effort to promote good stewardship at our collection sites. We will be filling and leveling disturbed areas using shovels and rakes. Fortunately, the ground is soft and most of the digs are less than 24" deep. Let folks who are interested know they will need to bring their lunch, water, field gear (hats, gloves, boots) and be prepared for the variety of fall weather (hot or cold) you can experience in the high desert. There is limited dry camping at the site, probably space for six to eight rigs (campers, trailers). Meet at the Brothers Rest Area on Highway 20 (MP 42.8) east of Bend @8:00 am or at the site @9:00 am. We will be observing any required COVID mitigation protocols, however the site is outside so distancing should not be a problem.

Attached is a flyer and two location maps which you can print and hand out to your club members at their future meetings. We want to encourage as much participation as possible, so please forward the project information to your club's newsletter editor and field trip coordinator for email distribution.


ALL MEMBER CLUBS ARE INVITED TO HELP WITH SITE RESTORATION ON NATIONAL PUBLIC LANDS DAY

Meet at the Brothers Rest Area on Highway 20 (MP 42.8) east of Bend @8:00 am or at the site @9:00 am. Bring lunch, water and your field gear. Be prepared for hot or cold high desert fall weather. You will also need a long handle shovel and short tine rake. We will fill and level earlier digs. The ground is soft and the holes are less than 24" deep. We will be observing any COVID mitigation protocols for the safety of participants.

<u>Directions</u> – Take Highway 20 east to Van Lake Road. Turn north and follow Van Lake Road 10.5 - 11 miles to SE Price/Twelve Mile Road and turn right. Follow Price Road about 2 miles to the site. It is 22 miles one way from the Brothers Rest Area to Hampton Butte.
